Subject: ReBOOT Grant – American Legion Post 239

EXECUTIVE SUMMARY

This Resolution authorizes the distribution of ReBOOT funds to the American Legion Post 239 and waives the previous requirements for the ReBOOT grants.

RECOMMENDATION

Introduce and approve as presented.

BACKGROUND

During the May 3rd City Council meeting, City Council discussed the financial impacts the American Legion has experienced during the coronavirus pandemic and expressed interest in providing funding to assist them with carrying out their activities to serve veterans and the community. The ReBOOT grant program, which was put in place to assist businesses that were negatively impacted by the coronavirus, has unspent funds in the program. City Council asked that legislation be prepared to authorize the distribution of \$14,000 in ReBOOT Grant funding to the American Legion. Passage of the attached Resolution would accomplish that request by authorizing the distribution of ReBOOT dollars to the American Legion and waiving any previous requirements related to the ReBOOT grant.

The City has provided grant funding to nonprofits that serve the Worthington community for many years. The established grant programs require the nonprofits to provide a written description (proposal) describing how they will use the public funds and the public benefit that will be achieved. In many cases, the City also requires a year-end report documenting how the funds were actually used. Staff

would recommend that the American Legion Post similarly be required to provide a short explanation of the proposed use of the funds prior to distribution and provide a year-end summary of the actual use.

FINANCIAL IMPLICATIONS

The amount of funding (\$14,000) is currently encumbered in the Economic Development fund for the purpose of ReBOOT Grant funding and would be distributed to the American Legion Post 239.

Approving Funding from the ReBOOT Worthington Grant Program to Support the American Legion Post 239.

WHEREAS, there remains a balance of \$14,913 in previously appropriated funds for the purpose of funding the ReBOOT Worthington Grant Program; and,

WHEREAS, the Worthington City Council does desire to waive any previously established program policies for the Worthington ReBOOT Grant Program and authorize the expenditure of \$14,000 of remaining ReBOOT Funds from the Economic Development Fund to support the American Legion Post 239.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Municipality of Worthington, County of Franklin, State of Ohio:

SECTION 1. That City Council does hereby award \$14,000 of remaining ReBOOT Worthington Grant funds to the American Legion Post 239.

SECTION 2. That previously established Worthington ReBOOT Grant program requirements are hereby waived for the grant to the American Legion Post 239.

Subject: **High North - Development Agreement**

EXECUTIVE SUMMARY

This Ordinance authorizes the City Manager to enter into a Development Agreement with DRP Worthington, LP, to support the redevelopment of the Shops at Worthington Place into High North, a mixed-use project located at 150 W. Wilson Bridge Road.

RECOMMENDATION

Introduce for public hearing on May 17, 2021.

BACKGROUND/DESCRIPTION

Property Information

The Shops at Worthington Place were originally constructed in the mid 1970's and have been renovated numerous times over the past five decades. The property transferred ownership at the end of 2019, and the new owner, DRP Worthington, LP, (DRP) plans to redevelop the site into a mixed-use development called High North. This redevelopment project would include demolishing portions of the existing mall, constructing new restaurant/retail space, and constructing up to 125,000 square feet of Class A office space with a structured parking garage.

There is approximately 138,000 sq. ft. of leasable area in the mall today. Of this, approximately 45% of the mall space is not producing revenue and overall is underperforming. Previous improvements and changes in use have enabled the eastern portion of the mall to operate at a higher level than the rest of the mall. The western side and interior corridors of the mall continue to struggle. The site also suffers from poor pedestrian and vehicular flow throughout the site.

Worthington Office Market

The City currently has a 9% office vacancy rate, excluding the former Anthem building on High Street. The City has approximately 2 million square feet of commercial office space, however only about 1% of that space can be considered 'Class A' space. The average age of office space in the City is approximately 45 years old. The remaining office space throughout the City is considered Class B and Class C office space. Additionally, the largest contiguous office space available in Worthington, excluding the Anthem property, is approximately 13,401 square feet in size. Without newer and larger spaces, the Worthington community will struggle to attract and retain larger employers that are needed to support the City's tax base.

FINANCIAL IMPLICATIONS/FUNDING SOURCES

Development Agreement

Given the City's heavy reliance on income tax revenue to support City services, City representatives have been in discussions with DRP regarding the redevelopment, which will help address some of the limitations in the Worthington office product described above. The partnership between the City and DRP is described in the proposed Development Agreement. The purpose of the Development Agreement is to detail the obligations of the City and DRP and to specify the standards and conditions that will govern the redevelopment of the property. This is an overarching agreement that ties the rezoning and redevelopment of the property to the financial incentive structure. Subsequent incentive agreements will come to City Council for approval at a later date.

Tax Increment Financing/Debt Issuance

The City proposes to support the High North office building by issuing capital facilities bonds to finance the construction of a 4-story, 542-space public parking garage. The debt obligation would be repaid using a combination of new income tax revenues from High North employers, as well as from Tax Increment Financing (TIF) revenues generated by the increased property value at the site.

This project represents a good source of incremental increase in property tax revenue. Through the use of this proposed TIF, the City can capture and redirect the incremental tax revenues to assist with the substantial costs associated with the construction of the garage. It is estimated that the parking garage will cost approximately \$15 million, plus costs associated with the City's bond issuance.

In order to create the TIF, City staff will be recommending in the coming weeks that the Worthington City Council adopt an enabling ordinance to exempt 100 percent of real property taxes, for a 30-year period, on improvements made to parcel 100-006788, or the new parcel once the anticipated subdivision occurs. The City estimates that the true value of the incremental improvements to the parcel associated with Phase 1 of the redevelopment project will be approximately \$19.3 million. In conjunction with the exemption, the TIF requires the property owner to make payments in lieu of taxes in the amount they would otherwise pay in taxes.

The City intends to structure this TIF with the Worthington School District receiving 25% of the payments in lieu of taxes, with the remaining funds being deposited into the City's TIF Fund (see ORC §5709.82(C)(2)). A supplemental Compensation Agreement will also be considered to help offset diverted property tax payments foregone property tax revenues.

The Worthington School Board will consider this request for support at their June board meeting.

Venture Grant

It is anticipated that Venture Grant assistance may be needed to help offset the total cost of constructing a Class A office building and to assist DRP in attracting future employers. Any grant would be required to be performance-based and conditioned on DRP meeting minimum payroll commitments. Additional approval by City Council would be required at a future meeting.

Offsite Public Improvements

Under the Development Agreement, the City will reimburse DRP for offsite public improvements and enhancements associated with the High North project, up to a maximum amount of \$1,500,000. These improvements include a Worthington monument sign just north of Kroger, brick columns and decorative fencing along High Street, earthwork, plantings, accent lighting, and pedestrian paving at the Wilson Bridge Road intersections. The funding source for this work will require further discussion by the City.

PREVIOUS LEGISLATION

At its April 19, 2021 meeting, City Council approved the rezoning of the site from the C-2 District (Community Shopping Center) to a Planned Use District (PUD) to accommodate the redevelopment of the site in two phases.

ORDINANCE NO. 18-2021

Authorizing the City Manager to Enter into a Development Agreement with DRP Worthington, LP.

WHEREAS, this Council desires to encourage the redevelopment of parcel number 100-006788, The Shops at Worthington Place, located at 150 W. Wilson Bridge Road (the "**Property**"), to further the economic development goals of the City in a manner that is consistent with the existing neighborhood; and,

WHEREAS, DRP Worthington, LP (the "**Developer**") desires to redevelop the Property into a mixed-use development called High North, featuring approximately one hundred and ten thousand (110,000) square feet of restaurant or retail space, and approximately two hundred fifteen thousand (215,000) square feet of Class A office space (collectively, the "**Project**"); and,

WHEREAS, The Project will be developed in accordance with PUD 02-2020 as passed by City Council on April 19, 2021; and,

WHEREAS, in connection with the administration of any financial incentives and the Planned Unit Development, the City and the Developer desire to execute a development agreement (the "**Development Agreement**"); and,

WHEREAS, the City seeks to increase employment opportunities and to encourage establishment of new jobs in the City, in order to improve the economic welfare of the City and its citizens, in furtherance of the public purposes enunciated in Article VIII, Section 13 of the Ohio Constitution; and,

WHEREAS, this Council desires that the Project be constructed, pursuant to the terms of the Development Agreement;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Municipality of Worthington, County of Franklin, State of Ohio:

SECTION 1. The City Manager is hereby authorized to execute the Development Agreement on behalf of the City with DRP Worthington, LP, and/or any related entity formed for the specific purpose of developing said Property, which includes provisions regarding the construction of the Project, administration of the PUD, financial incentive structure, and the undertaking of offsite improvements. The City Manager and other appropriate City officials are further authorized to provide such information and to execute, certify or furnish such other documents, and to do all other things as are necessary for and incidental to carrying out the provisions of the Development Agreement.

ORDINANCE NO. 18-2021

SECTION 2. The City Manager, the Director of Finance and the Director of Law, and any other City official, as appropriate, are each authorized and directed to sign any other documents, instruments or certificates and to take such actions as are necessary or appropriate to consummate or implement the transactions described in or contemplated by this Ordinance.

SECTION 3. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 4. That notice of passage of this Ordinance shall be posted in the Municipal Administration Building, the Worthington Library, the Griswold Center and the Worthington Community Center and shall set forth the title and effective date of the Ordinance and a statement that the Ordinance is on file in the office of the Clerk of Council. This Ordinance shall take effect and be in force from and after the earliest period allowed by law and by the Charter of the City of Worthington, Ohio.

Subject: American Legion Post 239 Liquor Permit Request

EXECUTIVE SUMMARY

City Council will discuss whether to request a hearing by the Ohio Division of Liquor Control on the advisability of issuing D2 and D3 liquor permits to the American Legion Post 239, located at 700 Morning Street, Worthington, Ohio.

BACKGROUND

The American Legion Post 239 has informed the City that it has applied for new liquor permits to allow small events such as anniversary celebrations and retirement parties by the general public at their facility. Its current liquor permits restrict the serving of alcohol to its members. Some neighbors of the Post have expressed concerns regarding the new liquor permits.

The City received notice from the Ohio Division of Liquor Control of the American Legion's D2 liquor permit request on March 17, 2021. As is our typical process, City staff verified with the Division of Police that there were no outstanding causes for concern. The request was then included on the April 5, 2021 City Council agenda as a Policy item. In response to the concerns raised by neighbors, City Council approved a motion to request a 30-day extension to further consider the situation. The extension request was granted by the Ohio Division of Liquor Control on April 16, 2021, with an expiration date of May 16, 2021. This item is returning to the City Council agenda for a decision as to whether to request a hearing.

The City also received notice from the Ohio Division of Liquor Control of the Legion's request for a D3 liquor permit. The City deadline for responding to the

Division of Liquor Control on the D3 permit is also May 16, 2021.

A D2 liquor permit allows for the sale of wine and mixed beverages (up to 42 proof) for on premises consumption or in original sealed containers for carryout. A D3 liquor permit allows for the sale of spirituous liquor (over 42 proof) for on premises consumption only.

EXECUTIVE SUMMARY

Staff requests authorization to advertise for bids for the 2021 Street Improvement Program.

RECOMMENDATION

Motion authorizing the advertisement for bids

BACKGROUND

The Capital Improvements Program provides funding each year for the Street Improvement Program which involves curb and gutter repair, asphalt overlay, asphalt patching, roadway rejuvenation and miscellaneous concrete repairs. It also involves repair of sidewalks that do not meet standards for safety and condition, the cost of which is paid by respective adjacent property owners. The program does not involve the construct of new roadways, curbs, gutters and sidewalks, rather it is focused on maintenance of existing infrastructure. City staff have completed the review of the condition of existing infrastructure and compiled the proposed 2021 Program, which is attached and was distributed to City Council on April 29th. Staff is prepared to discuss the proposed program and asks permission to advertise for bids.

FINANCIAL IMPLICATIONS

The 2021 Capital Improvements Program includes \$900,000 for this project.

Subject: Proposed Body Worn Camera Program

EXECUTIVE SUMMARY

The Chief of Police will provide additional information on the policy development and implementation plans for the City's proposed body worn camera program.

BACKGROUND

In July 2020, City Council tabled an ordinance to appropriate funds for the purchase of body worn cameras for police officers to allow for more time to develop the details of how the cameras will be implemented and utilized. Since that time, additional research and consideration has been pursued regarding how to most effectively roll out body worn cameras. Information and recommendations were discussed with City Council on April 12th. The Chief of Police will address areas of concern raised during the previous Committee of the Whole meeting and provide a status update on the Division's research and policy development efforts.

FINANCIAL IMPLICATIONS

Ordinance No. 26-2020, which was tabled in July 2020, appropriates funds to purchase the cameras from the Law Enforcement Trust Fund. A discount on the equipment has been negotiated if purchased by the end of May 2021. The Ordinance is scheduled to be removed from the table at the next regular City Council meeting for a vote on the appropriation in order to take advantage of the discount.
