*Executive Summary:* This Resolution accepts a grant from the Federal Emergency Management Administration of \$238,190.48 for self-contained breathing apparatus and a self-contained breathing apparatus fill station and authorizes the City Manager to execute the necessary grant documentation. Previously, in the 2021 Capital Improvements Program, \$341,000 was budgeted for the SCBA equipment and filling station.
