EXECUTIVE SUMMARY

This Resolution adopts a job description for Engineering Project Supervisor.

RECOMMENDATION

Introduce and Approve as Presented.

BACKGROUND/DESCRIPTION

The engineering portion of the Service and Engineering Department has experienced strain from an increased number and type of projects pursued within the Capital Improvements Program. In recent history, workload that exceeded the abilities of the Engineering Division staff was absorbed by the Department's Administrative Assistant Position. With the retirement of that Administrative Assistant in January 2023, staff is recommending the conversion of that position to the Engineering Project Supervisor.

The Engineering Project Supervisor will handle the more technical/specialized work currently performed by the Administrative Assistant along with expanded right of way permitting and internal project management support.

Salary for the position will be within range 19, to be competitive in an strong local market for positions in the engineering field. Pay range 19 is \$73,310.12 to \$92,411.02.

The staffing chart adopted in the 2024 Operating Budget includes the Engineering Project Supervisor.

General Statement of Duties

Under the direction of the Director of Public Service, the PT Public Service Coordinator performs administrative duties involving a variety of responsibilities within the Department. They coordinate solid waste management programming including program planning, implementation, special projects, evaluation, and education, as well as serving as a liaison to the City's solid waste hauler.

The PT Public Service Coordinator assists in data collection and preparation of Department reports and projects, assists in the development and supervision of employee training and environmental and safety programs. EXECUTIVE SUMMARY

This Resolution allows the City Manager to enter into an agreement with the Ohio Department of Transportation (ODOT) for construction of a roadway safety improvement project.

RECOMMENDATION

Introduce and Approve as Presented.

BACKGROUND/DESCRIPTION

On December 20, 2023, staff received a letter from ODOT District 6 requesting the passage of legislation establishing Worthington's participation with ODOT for completion of a safety related improvement at the intersection of State Route 161 and Olentangy River Road.

In 2022, Worthington partnered with ODOT and the Franklin County Engineer's Office for an application to the State's High Safety Improvement grant program. That application proposed the addition of an eastbound right turn lane on SR 161 and the conversion of Olentangy River Road's southbound through/right lane to a through/right/left lane. The application was successful, and the project was awarded up to \$375,000 in grant funds. Worthington was the sponsoring agency for the grant and is serving as the Local Public Agency (LPA) administering the project's design stage. Construction oversight and administration will be performed by ODOT District 6.

Grant funds are covering the \$78,577 of engineering services and estimated \$204,000 of construction costs. Work is tentatively expected to begin in August 2024 and is estimated to require 45 days to complete. During the construction period traffic will be maintained along the adjacent roadways. The project reconfigures a shared use path at this intersection, requiring the path's closure between Alrojo Street and Olentangy River Road. Successful passage of this resolution is necessary to allow the City Manager to enter into agreement to allow ODOT to complete the project.

A Resolution requesting the Director of the Ohio Department of Transportation to Proceed with the Construction of Safety Improvements to the Olentangy River Road and State Route 161 Intersection (FRA-161-8.66, PID 119049).

WHEREAS, the State of Ohio has identified the need for safety improvements to the Olentangy River Road and State Route 161 intersection to convert the southbound Olentangy River Road through/right lane to a shared through/right/left lane and add an eastbound through lane/right lane on State Route 161, along with other associated work within the City of Worthington (the "Project"); and,

WHEREAS, the City of Worthington (the "City") partnered with the Ohio Department of Transportation ("ODOT") and the Franklin County Engineer's Office in 2022 to submit a grant application to the State of Ohio's Highway Safety Improvement Program and the Project has been awarded up to \$375,000 in grant funds with Worthington as the sponsoring agency for the grant; and,

WHEREAS, the City will be administering the Project's design and ODOT District 6 will perform the construction oversight and administration; and,

WHEREAS, the City desires that the Director of the Ohio Department of Transportation ("Director") proceed with the Project.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Municipality of Worthington, County of Franklin, State of Ohio:

SECTION 1. That City Council hereby determines that the Project is in the public interest and gives consent to the Director to complete the Project.

SECTION 2. That the City agrees to participate in the cost of construction, up to a maximum of \$375,000.

SECTION 3. That the City agrees to pay One Hundred Percent (100%) of the cost of those features requested by the City which are determined by the State and Federal Highway Administration to be unnecessary for the Project.

SECTION 4. That the City agrees that change orders and extra work contracts required to fulfill the construction contracts shall be processed as needed, the State shall not approve a change order or extra work contract until it first gives notice, in writing, to the City, and the City shall contribute its share of the cost of these items in accordance with the other sections of this Resolution.

SECTION 5. That the City agrees to pay One Hundred Percent (100%) of the cost to install and/or repair curb ramps at all necessary intersections to ensure compliance with the Americans with Disabilities Act.

SECTION 6. That upon completion of the Project, and unless otherwise agreed, the City shall: (1) provide adequate maintenance for the described Project in accordance with all applicable state and federal law, including, but not limited to, 23 USC 116; (2) provide ample financial provisions, as necessary, for the maintenance of the described Project; (3) maintain the right-of-way, keeping it free of obstructions; and (4) hold said right-of-way inviolate for public highway purposes.

SECTION 7. That the City Manager or Acting City Manager of the City of Worthington is hereby empowered on behalf of the City of Worthington to enter into contracts with ODOT pre-qualified consultants for the preliminary engineering phase of the Project and to enter into contracts with the Director of Transportation necessary to complete the Project.

SECTION 8. That upon the request of ODOT, the City Manager or Acting City Manager is hereby empowered to assign all rights, title, and interests of the City of Worthington to ODOT arising from any agreement with its consultant in order to allow ODOT to direct additional or corrective work, recover damages due to errors or omissions, and to exercise all other contractual rights and remedies afforded by law or equity.

SECTION 9. That the City agrees (1) that if Federal Funds are used to pay the cost of any consultant contract, the City shall comply with 23 CFR 172 in the selection of its consultant and the administration of the consultant contract; (2) to incorporate ODOT's "Specifications for Consulting Services" as a contract document in all of its consultant contracts; (3) to require, as a scope of services clause, that all plans prepared by the consultant must conform to ODOT's current design standards and that the consultant shall be responsible for ongoing consultant involvement during the construction phase of the Project; (4) to include a completion schedule acceptable to ODOT; and (5) to assist ODOT in rating the consultant's performance through ODOT's Consultant Evaluation System..

SECTION 10. That the City Manager, Acting City Manager, and Finance Director are each hereby authorized, acting singly or jointly, to take all actions, including without limitation entering into agreements, submitting applications for reimbursements or grant distributions, and making payment of appropriated funds, necessary for the completion of the Project in accordance with this Resolution and all applicable state and federal law.

SECTION 11. That the City Clerk is hereby directed to record this Resolution in the appropriate record book and to transmit a fully executed and certified copy of this Resolution to the Director of Transportation.

SECTION 12. This Resolution shall take effect and be in force from and after the earliest period allowed by law and by the Charter of the City of Worthington, Ohio.

EXECUTIVE SUMMARY

This Ordinance appropriates funds from the Capital Improvement Fund unappropriated balance to pay the costs of the Fiber Connectivity Project and all related expenses and determines to proceed with said project (Project No. 758-24).

RECOMMENDATION

Introduce for public hearing on January 16, 2024.

BACKGROUND/DESCRIPTION

A new, expanded investment included in the approved CIP is a fiber optic connectivity project in 2024. This project takes advantage of the opportunity to expand upon a City of Hilliard fiber optic project that will run through Worthington to connect to a data center northeast of Worthington. The project will extend fiber from Hilliard's project at SR-161 and High Street south into the central business district area of Old Worthington, providing for future utilization of the fiber for traffic signal connectivity and expanded Wi-Fi capacity. Project objectives include:

- Connecting three buildings, one of which is not currently connected and the other two for the purpose of improving redundancy/diversity;
- Connecting several traffic signal cabinets along 161; and
- Creating a foundation for additional improvements planned for 2025, including improving Wi-Fi access in Old Worthington, providing a diverse connection to NRECC, and connectivity to Hilliard and Westerville for potential shared services opportunities.

FINANCIAL IMPLICATIONS/FUNDING SOURCES

\$245,000 is being appropriated from the Capital Improvements Fund Unappropriated Balance to Account No. 308.3010.533488 to pay the cost of the Fiber Connectivity Project (Project No. 758-24). Funds were included for this project in the 2024 Capital Improvements Program.

EXECUTIVE SUMMARY

This ordinance appropriates funds for a Bicycle Boulevard Pilot Project on Greenglade Avenue and Highland Avenue.

RECOMMENDATION

Introduce for Public Hearing January 16, 2024.

BACKGROUND/DESCRIPTION

Worthington's Bicycle and Pedestrian Master Plan identifies a network of neighborhood streets as potential bicycle boulevards. At the December 11, 2023 committee of the whole, staff provided an update on a feasibility study for implementing bicycle boulevards in Worthington. Based on that study, staff and the Bicycle and Pedestrian Advisory Board recommend moving forward with a pilot Bicycle Boulevard project.

The project will involve traffic calming on Highland Avenue and Greenglade Avenue, Community outreach and education, and an analysis of the pilot's effectiveness at promoting bicycle and pedestrian safety.

Staff will contract with Burton Planning Services to assist with data collection, analysis, and public outreach. Consulting services will be funded through the Capital Improvements Program's allocation for Bike and Pedestrian Improvements up to \$40,000.

Service Division staff will install and maintain the traffic calming features for this pilot. Those will include pavement markings, speed cushions, and signage.

Equipment and materials will be funded from the Capital Improvements Program's allocation for Bike and Pedestrian Improvements.

FINANCIAL IMPLICATIONS/FUNDING SOURCES (if applicable)

\$140,000 from the Capital Improvements Program's 2024 allocation for Bike & Pedestrian Improvements.

EXECUTIVE SUMMARY

This Ordinance appropriates funds for the construction of the Park Overlook Waterline Improvements in the Colonial Hills neighborhood.

RECOMMENDATION

Introduce for Public Hearing on January 16, 2024.

BACKGROUND/DESCRIPTION

In 2020 Strand Associates was engaged to prepare a comprehensive study of Worthington's water system. That study evaluated the condition of our public water main inventory by considering age, material, history of breaks, and relative importance to the community. The study identified and prioritized 49 separate water main replacement projects. This is the 2nd of those projects the City will be undertaking.

The project includes replacement of 1,800 feet of aging water lines along Park Overlook Avenue, Andover Street, and Indianola Avenue. Water services for sixty-one homes will be transferred to the new mains upon completion of work.

Staff will open sealed bids on January 5th with anticipated public hearing and award by council on January 15th. Construction is expected to occur over a roughly 120-day period and be completed by October 30, 2024.

EMH&T was retained in 2022 for engineering design and construction administration

using funds from the 2022 CIP. Staff will be adding on-site construction observation and testing to EMH&T's scope for an additional amount not to exceed \$65,120 using funds appropriated with this ordinance.

The ordinance is being introduced with blanks for the firm and amount pending the results of the bids. This information will be available at the public hearing.

FINANCIAL IMPLICATIONS/FUNDING SOURCES (if applicable)

The 2023 Capital Improvements Program included \$1,348,000 for construction of the Park Overlook water line improvements.

EXECUTIVE SUMMARY

This Ordinance authorizes the placement of small identification markers adjacent to each tree on the Village Green.

RECOMMENDATION

Introduce for Public Hearing on January 16, 2024.

BACKGROUND/DESCRIPTION

Section 12.03 of the Charter of the City of Worthington states the construction, installation, erection or placement of any permanent structure on the Worthington Village Green requires approval of six members of Worthington City Council.

The Arbor Advisory Committee, along with Parks and Recreation Department staff, have been working on a project to create an Arboretum on the Village Green. This project proposes to place small tree identification markers adjacent to each tree on the green which would identify the tree and include a QR code or link to enable visitors to learn more about the tree. This would be done as a part of a larger project creating a Worthington Village Green Arboretum. The Arboretum would have the following objectives:

- To preserve and care for the current and future trees on the Village Green.
- To provide education to visitors about basic tree planting, maintenance, and care.
- To celebrate tress through events such as Arbor Day.

The arboretum development would be overseen by the City of Worthington staff/arborists and the Arbor Advisory Committee. A catalogue of trees and shrubs would be kept in a computer database and available on-line for people who would like to learn more, identify the species they see, and more about tree planting and care.

City arborists and the Arbor Advisory Committee are recommending approval of the Ordinance.

Funding Source

The markers and their installation would be funded through existing city funds.
