<u>Executive Summary</u>: In September 2018, the City issued \$4,460,000 of bond anticipation notes to finance multiple capital improvement projects, as outlined in the 2018 – 2022 Capital Improvement Program. In lieu of issuing bonds in 2019, the City is issuing new notes in the anticipation of a full bond issuance in 2020.
