### 8. Policy Item(s)

a. American Legion Post 239 Liquor Permit Notice to Legislative Authority Executive Summary: The Ohio Division of Liquor Control notified the City that American Legion Post 239 has requested a D5 liquor permit. The City has a timeline to respond and either request a hearing, indicate that we are not requesting a hearing (No Objection) or determine that no action will be taken. Greater detail regarding this issue and advice on these options can be found in the attached staff memorandum.

#### b. Discussion Item - UMCH Focus Area Moratorium

Executive Summary: City Council voted on an ordinance for a moratorium related to the UMCH Focus Area on its January 18, 2022, meeting. This legislation was proposed for emergency passage, which means it would have taken effect immediately, and required a 6/7 vote of City Council for approval. The legislation did not pass. City Council requested that discussion of a UMCH Focus Area moratorium be placed on the agenda for further discussion. The previous legislation considered on January 18, 2022, is included for reference. Revised legislation is not provided as additional discussion, feedback and direction would be needed. No action is required.
