#### 7. Ordinance No. 32-2020 Boundary Adjustment NE Gateway

Agreeing to the Adjustment of the Boundaries between the City of Columbus and the City of Worthington by Consenting to the Transfer from the City of Columbus to the City of Worthington of Approximately 2 acres and the Transfer from the City of Worthington to the City of Columbus of approximately 1.3 acres located in the Vicinity of the Intersection between Lakeview Plaza Boulevard, Sanctus Boulevard, and Worthington-Galena Boad

Executive Summary: This Ordinance adjusts the boundary between the City of Worthington and the City of Columbus in the vicinity of the Northeast Gateway Project.

*Recommendation*: Motion to Remove from the Table, Amend and Approve as Amended.

*Legislative History*: Introduced July 13, 2020, P.H. set for September 8, 2020, Tabled at September 8, 2020 meeting

#### 8. Ordinance No. 35-2020 Stafford Village Subdivision

Approving the Subdivision of Property, Vacating/ Extinguishing an Existing Sewer Easement, and Accepting a New Sewer Easement (Northeast Corner of Hartford Street and East Stafford Avenue).

Executive Summary: This Ordinance approves the combination of ten (10) separate parcels to create one new parcel and vacates an existing 12" sanitary sewer line easement and plats a new 12" sanitary sewer line in a 20' easement.

### 9. Ordinance No 36-2020 Granting an Easement to Quikrete

Granting a Non-Exclusive Easement to The Quikrete Companies, LLC and Authorizing the City Manager to Enter into an Easement Agreement to Allow for the Use of a Portion of the Huntley Bowl Park property.
